    - ii. Antonio Dottore replaces Andrea Planamente as bank account signatory.
    - iii. Member of the Executive: Pina D'Orazio nominated by Stefano Pratola, seconded by Teresa LaRocca; Pina D'Orazio accepted the nomination; there being no other nominations and no objections, Pina D'Orazio was elected Member of the Executive.
